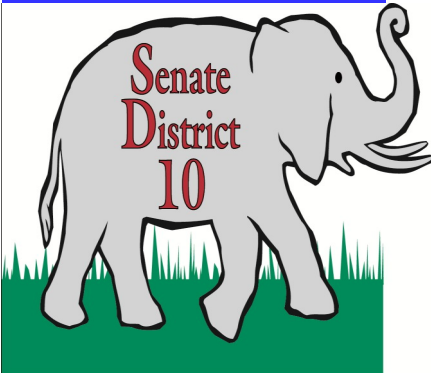

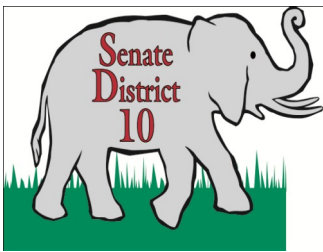

By the time I began school my family moved into a house where my grandmother grew up in a rural farm community in Peaster, TX. I spent all twelve years in the Peaster ISD, graduated from Peaster High School and began college at Weatherford Jr. College.

As luck would have it, I was running out of money and laid out of school during the wrong semester and received a draft notice in the summer of 1966. At that time, the Vietnam War was building up, all draftees were being sent directly to Fort Polk, LA and then to Vietnam. My younger brother had already served a tour there in the Navy. I enlisted for four years in The Army Security Agency, a branch of Army Intelligence. Fortunately, that worked to my advantage. After basic training at Fort Leonard Wood, MO, I spent the rest of the first year training at Fort Devens, MA and was honored to join 27 of my fellow classmates on a year long tour at Shemya Alaska. Shemya is a 2 ½ X 4 mile island located at the western tip of the Aleutian Islands where we monitored and tracked Soviet intercontinental ballistic missile tests. I spent the last two years of my military duty at Two Rock Ranch Station, Petaluma, CA, about 50 miles north of San Francisco. After completing my military obligation I moved back to Texas, finished college at UTA, receiving a BBA in Accounting, and have lived in Arlington since. Along the way, I married, had two sons but was single again in the early eighty's. I was single almost twenty years but remarried and have now been happily married eleven years to my wife Sandy.

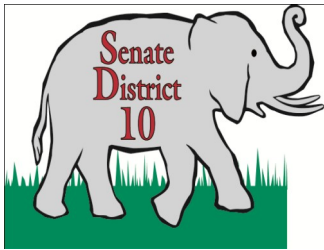
I often wonder if my military experience, especially the experience I had working with military intelligence, or the turmoil of the 60's and 70's molded my conservative thinking. The process of copying and tracking Soviet missals was an eye opening experience that has stayed with me to this day. I had studied the wars of the world in school but with the experience of actually witnessing a country at war, as we were with Vietnam, and another country shooting missals and testing war heads that can wreck havoc on the rest of the world; I began thinking much more globally than the rural farm community where I grew up. The era of the 60's and 70's was a bit different experience but the looting of schools, destruction of private property and public buildings by the protesters was definitely not the way I had grown up. Destruction of property, especially property of others was not the way to express or settle your grievances. I was curious about the hippies in and around the San Francisco area, so much so that my first stop on my first trip to the "City" was the infamous intersection of Haight and Ashbury Streets. Our military haircuts made us a bit of an oddity for the Haight-Ashbury area but not so much so that a fellow Texan from Houston, seeing the Texas plates on my car, walked up and wanted to know where I lived in Texas. Maybe the novelty was because I was actually driving a car when most of them seemed not to have one, but I think it was the haircut. As it turned out, they weren't the rowdy, destructive bunch we were used to seeing on the evening news, just different. It was definitely a period of growing up and learning that the world was not so simple and that all people on this earth do not share the same views of life as this country boy from Peaster, TX.

If there was a defining moment, more than anything else, I think the military experience drove me to become more active in politics. I remember the 1960 Kennedy-Nixon election while in high school, only because Kennedy was Catholic, and I was a first semester freshman college student when he was assassinated. I'm relatively sure that both my parents voted Democrat, more so because, for all general purposes, there wasn't a Republican party in Texas until the early to mid seventy's. You were either a conservative Democrat or a liberal Democrat. My parents, both devout Baptists, had a real problem voting for John Kennedy, "a Catholic," but the addition of Lyndon Johnson on the ballot as Vice President sealed the deal. Voting Republican for Richard Nixon was not an option for my parents. However, for them, it must have been a very serious moral dilemma. It wasn't until the 1967 election of Richard Nixon that I really took notice of the presidential election. By that time I had served a year in the military and was witnessing the escalation of the Vietnam War. My vote, much to the dismay of my parents, was for a Republican and I've never turned back. I attended my first district and state Republican convention in 1975 and was first elected as a precinct chair in the late 1980's. As best I remember, I was a precinct chair in North Arlington for about 5 years. Then I moved to South Arlington. It wasn't until I remarried and moved back to North Arlington that I became more active in Republican politics and was graciously handed the precinct chair by Ralph Brotherton.

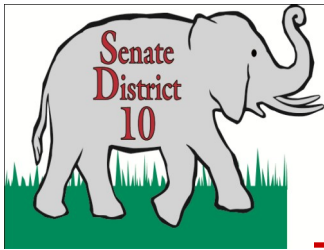

Michael Smith of Heritage Alliance gave a very informative and helpful presentation on how to mobilize the grassroots and how each of us can make a difference in every election cycle.

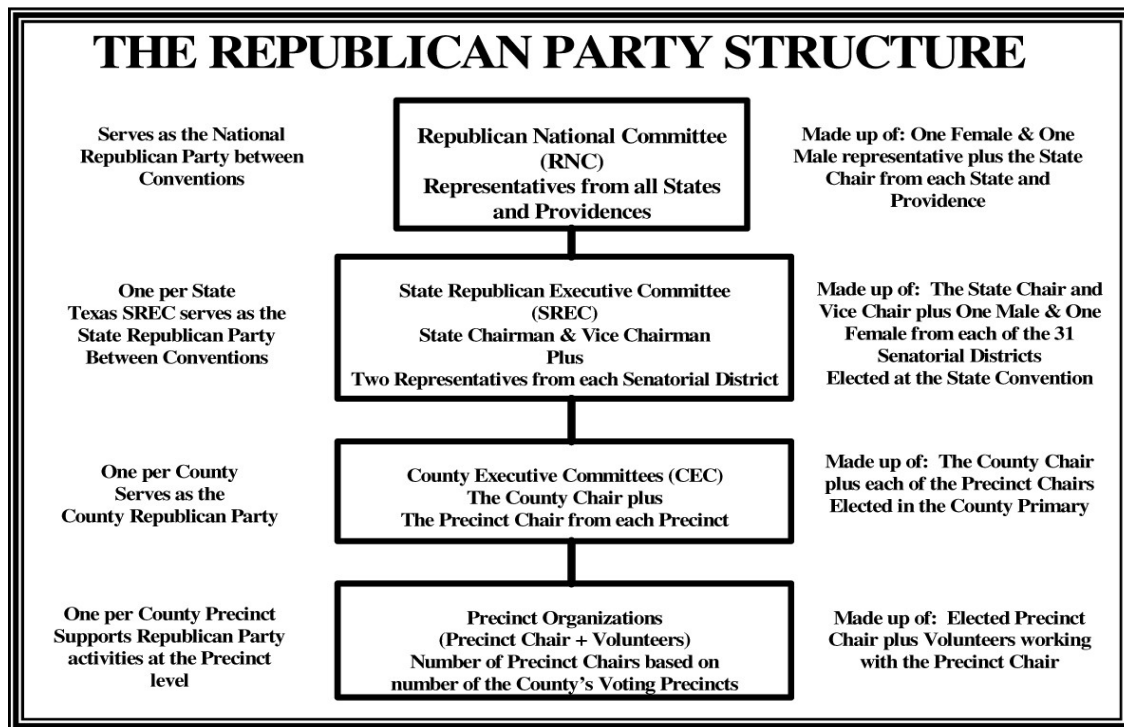

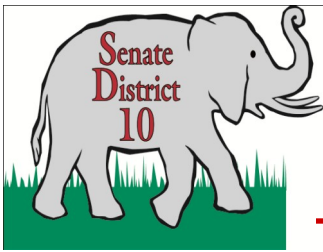


Northwest Republican Club officers at the November 11th meeting: (left to right) Mike Young, Nina Spears & Matt Krause

**Resolution Passed By The
State Republican Executive Committee September 25, 2010**

Resolution Supporting a Unified Republican Caucus Choice for Speaker of the House

Whereas, the primary function of the Republican Party of Texas is to elect candidates that embrace the principles articulated by the Republican Party of Texas Platform and to enact those principles legislatively; and

Whereas, grassroots Republicans have worked tirelessly to elect Republicans all across our great State only to have a minority of those Republicans confer with the opposing party in the selection of Speaker of the House, thereby negating the hard work of its grassroots; and

Whereas, the Republican Party of Texas has made great strides in assisting our Republicans in the legislature with more energy and determination to increase our representation of Republicans in the legislature this coming November; now, therefore, be it

Resolved, that the members of the SREC support, upon the certification of the November elections that House Republicans caucus together before the vote for Speaker of the House is commenced and select from among its Republican members a unified selection for Speaker of the House; be it further

Resolved, that Republican House members and Republican House candidates be given the opportunity to sign this resolution to show support for a unified Republican majority to select the Speaker of the House of Representatives for each legislative session as long as Republicans can maintain the majority representation in the House; and, be it further

Resolved, that at the close of business of the first day of December of each even numbered year, the Republican Party of Texas make note and prepare a tangible commendation of each House Members commitment at the December quarterly meeting of the SREC for those House Members support and defense of the will of the grassroots Republicans in selecting a Speaker of the House from among a unified Republican caucus.

RESOLVED, that a copy of this resolution be delivered by electronic mail to each Republican member of the Texas House of Representatives and Republican candidates for House for their signature or posted on the Republican Party of Texas website in a secure means which allows only those members or certified candidates to sign on electronically.

REFLECTIONS OF A CHIEF JUSTICE

Chief Justice, Second Court Of Appeals (Ret.)



In the fall of 1993, when I first announced my decision to run for Chief Justice of the Second Court of Appeals against a long-time incumbent Democrat with a familiar name (John Hill), few people believed that I had a chance of winning the 1994 General Election. The political landscape at that time in Texas was much different than it is today. Democrats ruled. Ann Richards was Governor, Bob Bullock was Lieutenant Governor, the Texas House and Senate were under Democrat Party control, and with the exception of some seats on the Texas Supreme Court and the Court of Criminal Appeals, most of the other statewide offices were held by Democrats. The national scene was much the same. Bill Clinton was our President and the Democrats held the majority in both houses of Congress.

As the election year progressed, however, mainstream America developed an “anti-incumbent” mood thanks in large part to Bill Clinton’s liberal policies (sound familiar?) and Newt Gingrich’s “Contract with America.” And, in Texas, we were fortunate to have an exciting political newcomer with a famous name and instant popular appeal at the top of the Republican ticket running for Governor -- George W. Bush. Texans, and the rest of the nation, were ready for change and the 1994 elections proved to be one of the most sweeping in our country’s history.

The year 1994 was certainly a memorable time to be a Republican candidate, and for me, it was a fortunate time as well. Timing is everything in politics, and that is certainly true in my case. Thanks to my surprise “upset” victory that year, and the confidence the people of Texas placed in me by re-electing me twice, I had the singular honor of serving as the Chief Justice of one of Texas’ finest appellate courts for the next fifteen years. While serving in that office, I not only had the privilege to participate in making many important legal decisions, but I had the opportunity to work with many good people of high integrity and commitment to public service. My years in public office rank among the most rewarding years of my life. I dearly loved serving the people of the Second District of Texas as Chief Justice, and the decision I made to retire from the bench last year was one of the most difficult I have ever made.

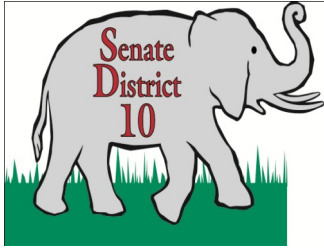
Much like 1994, when I went from private citizen to elected official, my transition this year from public life back to being a private citizen has been an exciting challenge. It has also been humbling. For example, earlier this year my 10 year old status conscious granddaughter told Diane (“Mimi”) that when she heard I was no longer going to be a judge she took me off her “most important people list.” As the late comedian Rodney Daingerfield always said, “I get no respect!”

Seriously, what I feel today as I reflect on my years on the bench is a mixture of immense pride, deep gratitude, and sincere humility.

I feel an enormous sense of *pride* for having had the unique opportunity to serve so many years in what I consider to be the noblest of all professions with some of the best judges and public servants in the state. I am proud of what I, and the other Justices with whom I served, accomplished as an appellate court in administering fair and impartial justice in the literally thousands cases that we decided, and for the improvements that we were able to make to the Court’s efficiency and productivity through the imple-

mentation of new rules and policies, organizational changes, and the modernization of our Court's technology. And I am proud of the fact that during my tenure as Chief Justice, we were able to dramatically improve the morale and livelihood of the Court's staff through better pay and a more suitable facility in which to perform the work of the Court.

I am also deeply *grateful* for the trust that the people of the Second District placed in me to serve as Chief Justice of one of the largest and most respected appellate courts in the state. I am thankful for the support and guidance I received from my many friends in the Republican Party, the members of the Court, the trial judges who serve in the Second District, and the many legislators and other elected officials throughout the State of Texas that I met and worked with over the years. I am also grateful for the prayers, encouragement, and sacrifices that Diane made throughout the years so that I could enter public service. Above all, I am grateful to God for allowing me to realize my dream of being an appellate court judge -- a dream that I've had since my days 30 years ago as a Texas Supreme Court law clerk.

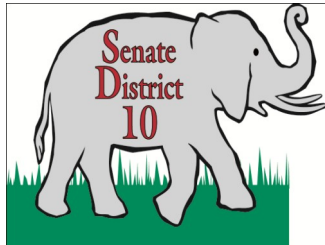
Finally, I am *humbled* by the fact that much of the good that was accomplished while I was Chief Justice was not through my own individual effort alone but, instead, with the able help of many others. To say that what the Court has accomplished over the past 15 years was a "collaborative effort" is not just a cliché, it is a fact. I worked with some of the smartest, most compassionate, and hard-working judges, court lawyers and clerks in the state, and I will always be grateful for my association with them and the lessons that they taught me. Few people get to do what they truly love in life, fewer still get to do what they love with people that they admire and respect. I am one of the fortunate few.

Those who know me well know the high regard I have for the judiciary and its work. In my view, there is no greater vocational calling than to correctly interpret and apply the law, administer justice, and adjudicate and resolve disputes for the purpose of promoting peace and protecting the welfare of our society. Nor is any other form of public service more important to a democracy governed by the rule of law. I agree with what President Thomas Jefferson wrote about the judicial branch more than two centuries ago: *"The dignity and stability of governments, the morals of the people and every blessing of society depend upon the upright and skillful administration of justice."*

The people of Texas are very fortunate to have so many judges like those in the Second District who are "upright and skillful" in the administration of justice. Because of their service, the state of our judiciary is strong! But, to keep it that way requires a continuing commitment on the part of our state leadership to provide the courts with adequate funding and competent salaries – two critical needs that are currently threatened by our state's current budget deficit.

To put my concerns in historical context, when I took office in January 1995, funding for the judicial branch represented less than one-tenth of 1% of the total state budget. Most courts were understaffed and what staff they had was underpaid. Until just a few years ago, we had to fight tooth and nail for every penny we received from the legislature. On top of this, our salaries were among the lowest in the nation. Although we received a small pay raise in 1999, a comptroller's report published in 2004 revealed

that the average tenure of judges on our state's 16 appellate courts was less than one full term. The reason cited for this pattern—low judicial pay.

To its credit, the Texas Legislature attempted to remedy both of these problems during the 2005 session. Thanks to Texas Supreme Court Chief Justice Wallace Jefferson's leadership, the legislature appropriated funding during that session that resulted in substantial salary increases placing us among the top five states nationally. In addition, we were fortunate the same session to obtain generous increases in our budgets. Those increases have been supplemented in the last two sessions with incremental increases that have allowed us to add staff and make their salaries more competitive.

Today, however, the judicial funding picture is beginning to look very much like it did before the 2005 legislative session. According to an annual report published by the National Center for State Courts, Texas judicial salaries now rank 25th in the nation. This puts Texas, the second largest state in the nation, well below much less populous and prosperous states like Alabama, Georgia, Tennessee and many others.

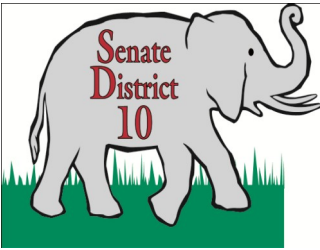
To make matters worse, Governor Perry and other members of state leadership have instructed all state appellate courts to submit budgets for the next biennium that include budget cuts of up to 10% -- reductions that if implemented will have a devastating impact on the courts' ability to function because it would require most courts to cut legal staff. As one Chief Justice from Houston recently observed, when the legislature is talking about court budgets cuts as big as 10%, "they are talking about [cutting] people."

Adding insult to injury, Chief Justice Jefferson has reported that if the proposed budget cuts are implemented they will have a severe impact on the Supreme Court's Access to Justice program-- which could mean that thousands of underprivileged individuals or families will not receive the legal services that they need.

I mention all of this because I believe that, as citizens who care about good government, we all have an obligation to do everything within our power to persuade the leadership of this state to allow the appellate courts to retain their current level of funding during this time of economic crisis. Cutting the funding of the already underfunded judicial branch should be the absolute very last resort after the budgets of all state agencies are examined.

I also believe that we must continue to offer whatever assistance we can in the fight to insure that judicial compensation in this state is proportionate to the size of our state, the weight and complexity of the our courts' dockets, and the overall importance of the work that our judges perform. Two legislative sessions ago the legislature created a commission for the very purpose of making recommendations on judicial compensation and the commission recommended in the 2009 session that salaries be increased. That recommendation, however, fell on deaf ears long before there was any talk of a recession. We cannot let that happen again. The continued strength and independence of our judiciary – both State and Federal – depends on us doing everything we can to make sure that it is supported by the legislative branch through adequate funding and compensation. I pledge to do all that I can in my new role as a "private citizen." I encourage each of you to do the same.

Thank you, again, for the high honor of allowing me to serve as your Chief Justice. Diane and I owe each of you a debt of gratitude for your loyalty and support we will never be able to repay.
